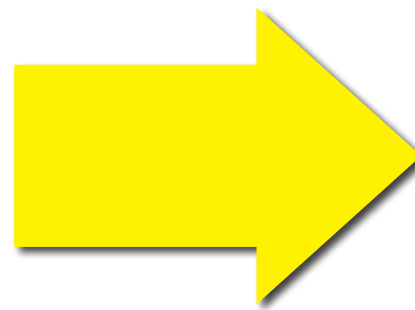

Where will Your Tax Dollars be SPENT for the next 10 years???

THEN

2006 – Nearly 67% approve Measure Z
 2006 – Over 75% approve Measure YY
 2007-2008 – 40 new officers hired
 2008-2009 – Violent crime drops 4.5%



NOW

2012 – City files for Bankruptcy protection
 2012 – Layoffs of most civilian support staff
 2012 – 53.3% increase in Homicides
 2012 – Violent Crime/Response times increase
 2012-2013 – Sworn staffing drops nearly 30%

Measure YY advises that the proceeds of Measure Z are to *“be used only to fund more police officers and support personnel, to fund anti-gang and anti-crime operations, including drug resistance education and supervised after-school youth activities.”*
